### **ORGANISATIONAL REQUIREMENTS TO THE INVITING PARTY:**

#### **1. Transfer.**

- Payment of air tickets in both directions. The exception is a small distance from the city, where the event is held. Details and nuances are discussed in more specific consideration of your proposal.
- The organizers of the event order and send the tickets in advance (no later than 2 weeks before the scheduled date of the event).
- The event organizers are required to grant a visa if it is necessary. The exception is the already existing valid visa for entry into the territory of a country. Details and nuances are discussed in more specific consideration of your proposal.
- Please indicate the data Aeroflot-Bonus (**DMITRY DOLGOV, 69637470**), when booking flights in the company "Aeroflot".

#### **2. Fee.**

Fee payment options:

- 100% advance payment is made no later than 2 weeks before the scheduled date of the event.
- 50% advance payment is made no later than 2 weeks before the scheduled date of the event. The remaining 50% shall be paid upon arrival to the city of the campaign before event. If payment is not made before the event, the performance is canceled! The first 50% of payment will be counted as a forfeit and not returned.
- The amount of the fee is discussed directly with the DJ or his director.

#### **3. Residence.**

- The hotel (Suite room), in that case, if the the DJ will stay more than 6 hours in the host city.

#### **4. Meals.**

- The inviting party provides three meals a day of the DJ on his request.
- All alcoholic and soft drinks at the expense of the inviting party.

#### **5. Meeting at the airport or railway station.**

- The inviting party meets the DJ at the airport or railway station and escorts him until departure.

#### **6. DJ`s safety.**

- The inviting party should ensure the safety of the DJ`s life and property during his stay in the host city and during his performance.

## **TECHNICAL REQUIREMENTS TO THE INVITING PARTY:**

**The equipment should include the following components:**

1. **Cd Player** (2 pieces), brand **PIONEER (2000, 1000 mk 3)**
2. **DJ Mixer** brand PIONEER 900 (800)
3. **DJ's sound monitors** (2 pieces), (power of not less than 350 W) standing at 1,5 meters distance (not further) from the DJ's place. Adjusting of the sound pressure of monitor should be carried out only with the DJ's console.
4. The location of equipment on the table:



**All equipment must be in working state and suitable for operation condition. In the case of non-compliance of the requirements for the functionality of equipment, in the future the DJ is not responsible for it!**

## **OTHER REQUIREMENTS:**

**STRICTLY prohibited any record of the DJ for any kind of media without the permission of the DJ, or his director! In the case of recording resolution by the DJ, release of the record in any medium is expressly prohibited, without the permission of the DJ, or his director!**

All other details and nuances are discussed in more specific consideration of your proposal.
